Questions & Answers

Q: WHEN DO I BEGIN PLAYING IN READY, SET, ACTIVATE?

A: You are automatically enrolled in the program the first day you join the business. The first day you join will count as your recruit month (Month 1 of the 3-month program).

Q: WHERE CAN I FIND MY END DATE FOR READY, SET, ACTIVATE?

A: You may find your end date by logging into the My.Tupperware system, click on the three-line menu on the left and go to My Business > Programs > Ready, Set, Activate.

Q: HOW MUCH IN SALES DO I NEED TO ACHIEVE THE NEXT LEVEL IN READY, SET, ACTIVATE?

A: To find the sales amount needed for your next level in Ready, Set, Activate, go to My.Tupperware, click on the three-line menu on the left and go to My Business > Program > Ready, Set, Activate.

Q: HOW DO SUBMITTED PERSONAL SALES COUNT IN THIS PROGRAM?

A: Sales submitted each month count toward that month's awards. This is not a cumulative sales program; each month stands alone.

Q: WHEN CAN I REDEEM MY AWARD?

A: Awards are available to redeem when the month in which you qualify for the level award is closed. These awards will show up for you by the Friday after the month closes.

Q: CAN I RETURN AN AWARD ONCE I'VE RECEIVED IT?

A: No, an award cannot be returned once a Sales Force Member has received it.

Q: HOW LONG WILL MY AWARD BE AVAILABLE TO REDEEM?

A: Your award is available to redeem for 30 days.

Q: DOES THIS AWARD COUNT AS A 1099 TAX ITEM?

A: Yes, the value of any award that you redeem will be included as a 1099 item on your tax statement from Tupperware.

Q: HOW DO I REDEEM MY AWARD?

1. You will receive an email with your unique Retail Credit Code.
2. This credit can be used to purchase any full-priced items in the current catalog.
3. Credit will be issued in the form of a Retail Credit Code. You will receive an email with this code and instructions for redemption.
4. The Retail Credit is available for redemption from when you receive the email until 30 days after you complete Month 3.
5. This Retail Credit can only be used within your Business Portal on a Non-Party Customer Order.
6. This Retail Credit has a one-time use and should be used in its entirety. Any amount that is not used cannot be used on a future order.
7. Shipping and taxes are applicable and based on the retail value of the order.

Q: WHEN CAN I BEGIN PLAYING FOR OTHER INCENTIVES?

A: Occasionally, some incentives may only be available to Established Consultants (those no longer playing in Ready, Set, Activate) and higher. For those, you would not be able to play for the incentive if the qualification period begins while you are still in Ready, Set, Activate. However, check Party Perks (where all information on current incentives is available) as there are often incentives also available to those in Ready, Set, Activate.
